Futureense Technologies Pvt Ltd, a company incorporated under the provisions of the Companies Act, 1956, bearing CIN No U74999DL2020PTC440942 having its registered office at 4435-36/4, 1ST FLOOR, ANSARI ROAD, Darya Ganj, Central Delhi, New Delhi, Delhi, India, 110002 represented by Mr. Vikas Gupta, Chairman and Managing Director (hereinafter referred to as the "**Program Partner or Futureense**" which expression shall, unless repugnant to the context or meaning thereof, shall mean and include its successors and permitted assigns), of the **Other Part**.

IIT MANDI and Program Partner are hereinafter collectively referred to as the "**Parties**" and individually as a "**Party**".

- D. The Parties hereto on their mutual consent have now agreed to enter into this MOU on the covenants as stated hereafter.




