### **THIRD NOTE OF AMENDMENT**

This Third Note of Amendment (hereinafter referred to as “Third Note of Amendment”) to the Agreement dated 23<sup>rd</sup> September 2022 (hereinafter referred to as “Agreement”) read with Note of amendment dated 18<sup>th</sup> April 2024 (hereinafter referred to as “First Note of Amendment”), Second Note of amendment dated 10<sup>th</sup> January 2026 (hereinafter referred to as “Second Note of Amendment”), is executed at New Delhi on this 17<sup>th</sup> Day of March 2026 by and between **National Skill Development Corporation**, (CIN: U85300DL2008NPL181612) and **Indian Institute of Technology, Mandi**.

First Note of Amendment and Second Note of Amendment are collectively referred to as “Note of Amendments”

Unless defined herein, the terms used but not defined herein shall have the same meaning as defined (if any) in the Agreement.

In pursuance of sub-clause 14.8-“Addendum” under clause 14- “Other Covenants” of the Agreement, the Parties hereby mutually agree to amend certain terms of the Agreement read with First Note of Amendment as mentioned hereinbelow:

1. The existing Clause No. 2 – “Curriculum Details” mentioned under Annexure-1: **Scope of Work, Rights & Obligations of The Parties** of the Agreement read with Note of Amendments is deleted and substituted with the following.
 

*2. **Course Details:** - Any Certification/ Online course / Changes in Roles and Responsibilities of parties and Financials based on course to course/Course related details etc. finalized between CCE IIT Mandi, NSDC and NSDC Implementing Partner shall be documented in the addendum duly signed between the Parties.*
2. The Parties hereby agree to add a new course titled “Minor Certificate Program in AI” by way of insertion of Annexure-1A to this Third Note of Amendment. Annexure-1A (Course Details and Financials), attached hereto, shall form an integral part of this Third Note of Amendment and shall come into force from the date of execution of this Third Note of Amendment.
3. Except as expressly amended and modified by this Third Note of Amendment, the covenants of Agreement read with Note of Amendments shall continue to be in full force and effect in accordance with the terms thereof.
