

## MEMORANDUM OF UNDERSTANDING ("MoU")

This Memorandum of Understanding ("MoU") is executed on this 28 day of February 2025 by and between:

- A. Indian Institute of Technology Mandi**, an Indian Educational Institute having the address, Kamand Campus, Distt. Mandi, Himachal Pradesh, 175075 (hereinafter referred to as "IITMandi", which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns [hereinafter called as PARTY 1] on the ONE PART.
- B. Pandit Deendayal Energy University (PDEU)**, a private university, having its headquarters located at Knowledge Corridor, Raisan Village, Gandhinagar 382 427, (hereinafter referred to as "PDEU") on the OTHER PART (who for the purpose of this MoU hereinafter individually referred to as 'PARTY' 2 and collectively referred to as the 'PARTIES').

WHEREAS PARTY 1 "IITMandi" is a reputed higher education institution named for teaching and research from its premises situated at Mandi, Himachal Pradesh  
And

WHEREAS PARTY 2 "PDEU" is a reputed energy and petroleum university counted among the top universities in Gujarat for Engineering, Science, Liberal Studies, and Management.

### 1. Nature of This MoU

In furtherance of their mutual interest in promoting their cooperation in the area of education and research, Parties may at their sole discretion enter into various contractual arrangements with respect to one or more of the following (collectively the "Objects"), from time to time:

- 1.1 Joint research collaborations, joint publication of scientific papers and educational materials resulting from the collaborations within program cooperation, and joint application for funding for collaborative projects from relevant funding agencies.
- 1.2 Participation in academic and co-hosting of lectures, meetings, seminars, symposia, conferences, and other such events.
- 1.3 Short-term non-degree programs such as executive programs, summer programs, and digital programs.
- 1.4 Exchange of faculty, students, and research scholars.
- 1.5 Student internship, projects, etc.
- 1.6 Collaboration in other areas is subject to mutual agreement.

7.1 The Parties shall act in all matters pertaining to this MoU as independent parties and nothing contained herein shall be deemed to create a partnership between Parties, nor constitute either Party the agent of the other or entitle either Party to commit or bind the other Party in any manner. Each Party specifically warrants and represents to the other Party that it shall not represent itself as an agent of the other Party.

## 8. Non Exclusivity

8.1 This MoU does not create any exclusive rights or obligations with respect to the Parties. Each Party, at their sole discretion, is free to enter into any similar arrangements as is envisaged under this MoU and any other arrangement, with any third party.
