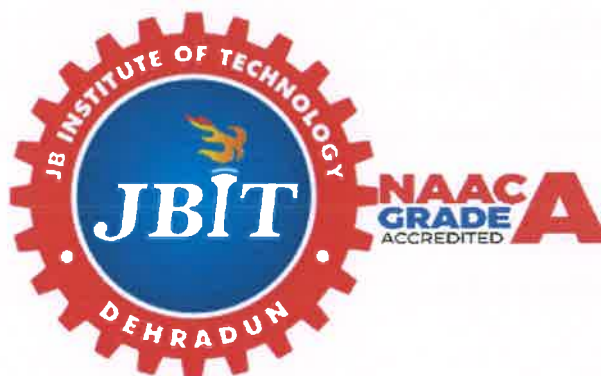

Memorandum of Understanding

This Memorandum of Understanding (MoU) is entered into on this 19th day of November, 2025, by and between:

JB Institute of Technology, having its campus at 23-Milestone, NH-7 Shankerpur, Chakrata Road, Dehradun, Uttarakhand-248197 (hereinafter referred to as "JBIT"), and

Indian Institute of Technology, Mandi, having its campus at Parashar Road, Tehsil Sadar, Near Kataula, Kamand, Mandi, Himachal Pradesh 175075 (hereinafter referred to as "IIT Mandi"), collectively referred to as the "Parties" and individually as a "Party."

1. Purpose

Recognizing the mutual benefits to be gained through a cooperative program promoting academic and research collaboration, both institutions agree to establish a formal partnership under the following terms and conditions:

The purpose of this MoU is to establish a framework for academic and research collaboration between JBIT and IIT Mandi, aimed at fostering mutual cooperation and promoting excellence in education, innovation, and research.

2. Areas of Collaboration

The second party agrees to collaborate in the following areas:

2.1 Academic:

- (a) To offer minor courses in advanced and emerging areas to students of JBIT, leveraging the expertise of IIT Mandi faculty.
- (b) IIT Mandi will design and deliver minor courses that align with contemporary industry and academic demands. These courses may be conducted in hybrid (online and offline) modes.

years. Thereafter it shall be automatically renewed each year; however, after the initial period either party may terminate the agreement by giving three months written notice of such intent.

If any Party intends to extend the term, such Party shall send a written notice to the other Party expressing its intent for extension at the end of the fourth (4th) anniversary of the date of this MoU and such renewal shall be prepared in writing and signed by both parties hereto.

8. General Provisions

1. This MoU does not create any legal or financial obligations between the Parties.
2. The Parties shall mutually ensure the confidentiality of shared information and data.

9. Notices
